**Nature of Procurement:** Works

**Mode of Procurement:** Local Competitive Bidding (LCB)

The Chief Executive Officer, SCRAM invites interested bidders/contractor to submit their qualification for undertaking works “Construction of Pedestrian bridge across Mat River to link WRC areas from Lungzawl at Bungtlang village”. The propose requirement is for 90 metres.

**Stage of bidding:** 2 Stage Biding

**1<sup>st</sup> Stage:** Interested bidders/contractors may submit their qualification documents as listed below. The project shall evaluate the documents confirming the experience and qualification of the bidders/contractors and shortlist them for the 2<sup>nd</sup> stage.

**2<sup>nd</sup> Stage:** The project shall invite bid (Request for Bid) on technical and commercial to the shortlisted/qualified bidders/contractors. Based on the combined evaluation (technical & commercial), the project may award contract to the most qualified bidder/contractor with a formal contract agreement.

**Necessary documents to be submitted for qualification criteria:**

**Experience:** The bidder shall be a registered firm under the Government of Mizoram/Quasi-GoM/ Autonomous body under the GoM legally in existence for at least 5 years who has undertake works/construction from a reputed firm/government/corporate. It shall not be debarred from any authority listed or engaged in fraudulent activities in the past.

Other required documentary evidence to be submitted by the bidder to confirm its qualifications to perform the contract is as follows:

- i. Legal registration certificate of the company/firm/partnership (Attach certificate of registration for company and partnership deed for firms/partnership)
- ii. Tax Clearance Certificate/Tax return submission evidence for the FY 18-19 or later or GSTR 3b form.
- iii. GST registration or business registration certificates;
- iv. Audited financial statements for the years 2017-18, 2018-19 and 2019-20;
- v. Copy of the contract or work order in the bidder’s name and title for supply of at least INR 30 lakhs. Number of contracts/purchase order in fulfillment of the requirement should be 3 or less in last 3 years (Attach copies of the contract/purchase order)
- vi. Power of Attorney authorizing signature of the bid by the bidder’s representative.

*(Failure to produce any of the specified documents or failure to comply with the experience shall be automatically rejected).*



**Last date of submission:**

Interested bidders/contractors shall submit their qualification documents no later than **14<sup>th</sup> September, 2021; 2:00 PM IST**. No late parties shall be entertained.

However, in case of unforeseen circumstances or changes in the qualification criteria, the Chief Executive Officer, SCRAM shall issue a notification in the local newspaper.

**Bid Security:** No bid security shall be required at this stage.

**Bid submission:** Bid shall be submitted in a sealed envelope, duly self-attested by the bidder/contractor in one copy. No electronic bid documents shall be accepted.

The project shall invite bid (Request for Bid) on technical and commercial to the shortlisted/qualified bidders/contractors. Based on the combined evaluation (technical & commercial), the project may award contract to the most qualified bidder/contractor with a formal contract agreement.

**Other necessary information:**

The bidder/contractor must clearly state the name of its firm/organization, registered office/address, contact number, email. The project shall not be held liable in case the bidder/contractor did not provide the required information/correct information.
