## Meeting Minute for the Bid Evaluation Committee For “Supply of Barbed Wire”

As entrusted by the Bid Opening Committee for Evaluation of Bids for “Supply of Barbed Wire” a meeting for the evaluation of bids (Request for bid) for “Supply of Barbed Wire” was held on 23<sup>rd</sup> February, 2022, 1:00 PM at the office chamber of the State Project Director, FOCUS. The meeting was chaired by the Deputy Director, AH&Vety, PMU, FOCUS and Chairman of the Evaluation Committee and was attended by other members of the evaluation committee. Unfortunately, the Technical Officer, AH&Vety, PMU, FOCUS was tested positive for COVID-19 and therefore Technical Officer, I.R,S&WC, PMU, FOCUS Mizoram was invited for technical evaluation.

The Committee evaluated the bids based on the requirement for pre-qualification and post-qualification issued on the Request for Bids (RFB) along with financial bid and sample product verification. Each bid was assigned to an evaluator and cross checked by other evaluator and countersigned by the Chairman of the Committee. Based on the outcome of the evaluations by the Evaluation Committee, the committee hereby prepared the Evaluation Report (**enclosed**) and made the following recommendations for award of contract.

Mehar Agencies offered : Barbed Wire of RK Wire Products Limited  
Hi-Tech offered : Barbed wire of Vismaya Integrated Farm Tech and Barbed Wire of TATA WIRON. Offer of TATA WIRON is not accepted as there is no manufacturer authorization letter.

### Recommendations:

The unit price (per kg) for Hi-Tech Sales and Service Pvt. Ltd. is Rs. 134.00/- and Mehar Agencies Pvt. Ltd. is Rs. 133.99/-. The difference in unit price is Rs. 0.01/- between the two.

On reviewing the sample product, Barbed wire of Vismaya Integrated Farm Tech offered by Hi-Tech Sale and Service Pvt. Ltd. is more preferable over Barbed Wire of RK Wire Products Limited based on its quality, strength and durability.

Therefore, based on the concept of Value for Money, the Evaluation Committee recommended to award contract for "Barbed wire of Vismaya Integrated Farm Tech" offered by "Hi-Tech Sale and Service Pvt. Ltd." with a cost of Rs. 24,12,000.00 (Twenty Four Lakh Twelve Thousand) (i.e, Rs. 134 per kg x 18000 kgs).




