Meeting minutes for the bid opening of Request for Qualification “Construction of Pedestrian Bridge”

A meeting for the opening of bid (Request for Qualification) was held on 16th September, 2021, 4:00 PM at the office chamber of the Chief Executive Officer, SCRAM and State Project Director, FOCUS (CEO & SPD, SCRAM-FOCUS). The meeting was chaired by the CEO & SPD, SCRAM-FOCUS and was attended by officials from PMU, FOCUS.

Attendance: Enclosed

At the onset, the CEO & SPD, SCRAM-FOCUS welcomed all members who participated the meeting and requested the Procurement Officer to give a brief narrative of the procurement process. The Procurement Officer highlighted the following information as how the procurement was undertaken and way forward to complete the process.

Background: The Chief Executive Officer, SCRAM invites interested bidders/contractor to submit their qualification for undertaking works “Construction of Pedestrian bridge across Mat River to link WRC areas from Lungzawl at Bungtlang village”. The propose requirement is for 90 metres.

Mode of procurement: Local Competitive Bidding (LCB). 2 stage bidding.

1st Stage: Interested bidders/contractors may submit their qualification documents as listed below. The project shall evaluate the documents confirming the experience and qualification of the bidders/contractors and shortlist them for the 2nd stage.

2nd Stage: The project shall invite bid (Request for Bid) on technical and commercial to the shortlisted/qualified bidders/contractors. Based on the combined evaluation (technical & commercial), the project may award contract to the most qualified bidder/contractor with a formal contract agreement.

The Request for Qualification was first advertised on 1st August, 2021 till 16th August, 2021 and re-advertised during 31st August, 2021 to 14th September, 2021; 2:00 PM due to Covid 19 issues and lack of competition.

Qualification Criteria:

Experience: The bidder shall be a registered firm under the Government of Mizoram/Quasi-GoM/ Autonomous body under the GoM legally in existence for at least 5 years who has undertaken works/construction from a reputed firm/government/corporate. It shall not be debarred from any authority listed or engaged in fraudulent activities in the past.

Other required documentary evidence to be submitted by the bidder to confirm its qualifications to perform the contract is as follows:

- i.** Legal registration certificate of the company/firm/partnership (Attach certificate of registration for company and partnership deed for firms/partnership)
- ii.** Tax Clearance Certificate/Tax return submission evidence for the FY 18-19 or later or GSTR 3b form.
- iii.** GST registration or business registration certificates;
- iv.** Audited financial statements for the years 2017-18, 2018-19 and 2019-20;
- v.** Copy of the contract or work order in the bidder's name and title for supply of at least INR 30 lakhs. Number of contracts/purchase order in fulfillment of the requirement should be 3 or less in last 3 years (Attach copies of the contract/purchase order)
- vi.** Power of Attorney authorizing signature of the bid by the bidder's representative.

Reason for rejection of qualification:

1. TZ Construction of Tuikual North, Aizawl, Mizoram is rejected due to non-compliance with the requirement stated in **para v of the qualification criteria-**

Copy of the contract or work order in the bidder's name and title for supply of at least INR 30 lakhs. Number of contracts/purchase order in fulfillment of the requirement should be 3 or less in last 3 years (Attach copies of the contract/purchase order).

Qualification without proper supporting document is automatically disqualified.

2. Lalroenga, IInd Class Contractor of Republic Veng, Aizawl, Mizoram is rejected due to non-compliance with the requirements stated in **para iv of the qualification criteria-**

Audited financial statements for the years 2017-18, 2018-19 and 2019-20.

Bank statement is not accepted as it is not an audited statement.

The Bid Opening Committee (BOC) verified all information and evaluate as per the criteria issued.

Way forward:

The Bid Opening Committee on accepting the qualification of the qualified firms hereby request the Procurement Officer and Engineering Cell, FOCUS Mizoram to prepare the Request for Bids (RFB) including Technical & Commercial proposal to be issued to the shortlisted firms within the month of September, 2021.


