## Meeting minutes of the Evaluation Committee of "Construction of Pedestrian Bridge"

As entrusted by the Bid Opening Committee, a meeting of the Evaluation Committee for "Construction of Pedestrian Bridge" was held on 8th November, 2021, 2:30 PM at the office chamber of the State Project Director, FOCUS-Mizoram. The meeting was chaired by the Deputy Director, LR,S&WC and was attended by all Evaluation Committee except the Accounts Officer who was attending an urgent work.

The Evaluation Committee evaluated the bid submitted by the bidders on technical compliance and financial (BoQ) as per the RFQ issued. Name of the bidders are as under:

- 1) Rolins Engineering, Ramhlun North, Basic Mual, Aizawl, Mizoram.
- 2) Infrastructure Planning & Designing Consultant (IPDC), Damveng(Thakthing), Aizawl, Mizoram.
- 3) Creative Minds, Chanmari West, Aizawl.
- 4) Perpetual Construction & Consultancy Services, Kulikawn, Aizawl, Mizoram.

Based on the outcome of the evaluation, the Evaluation Committee concluded with the following decisions:

- 1. All bids were accepted as substantially responsive.
- 2. On technical compliance, Perpetual Construction & Consultancy Service and Creative Minds were rejected as there is no proof of work experience as mandated in para 12 (a) of RFQ.
- 3. Rolins Engineering and Infrastructural Planing & Designing Consultant (IPDC) were accepted for further evaluation.
- 4. Based on the evaluation of the Bill of Quantities (BoQ), Rolins Engineering is the lowest bidder with a total value of INR 16,47,771.00 for the contract.

## Recommendation

The Evaluation Committee on evaluating the technical compliance and financial estimates has recommended Rolins Engineering, Ramhlun North, Basic Mual, Aizawl, Mizoram who is the lowest bidder and in compliance with the requirement for a total value of INR 16,47,771.00 for award of the contract.
